# **Privacy Policy**

Thank you for choosing to be part of our community at Cryptone LLC, doing business as ("CRYPTONE", "we", "us" or "our"). We are committed to protecting your personal information and your right to privacy.

This privacy policy explains how we collect or uses the personal information of persons who downloads and uses our Driver mobile application "Route app" and service platform used by merchants, altogether referred as "Service", and information of customer from merchants which have subscribed our service.

In the privacy policy if we refer to

- "App", we are referring to application of ours, "Ally One Route", that reference or links to this policy, including any listed above
- "Services", we are referring to our App, and other related services, including any sales, marketing or events

The Personal Information that we collect is used for providing and improving the Service. We will not use or share your information with anyone except as described in this Privacy Policy.

The whole purpose of this policy to kept you aware about what information we collect, how we use it and what rights you have in relation to it. If you have any non-agreeable terms in this policy please feel free to discontinue the use of our services with immediate effect.

#### Information Collection and Use

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information, including but not limited to , by which you may be personally identified, such as name, postal and physical address, email address, telephone number, coarse and precise geo-location by which you may be contacted online or offline ("personal information"). We collect this information using the Admin Panel (Web Version) directly from you when you book a delivery order from a merchant registered with us. The information that we request will be retained by us and used as described in this privacy policy. The app does use third party services that may collect information used to identify you like Google Location services and for sending delivery confirmation messages from merchants once a product is delivered to you. The App does capture the image of the package delivered to the customer as of proof of delivery while delivering it to the customer.

### Log Data

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing our Service, the time and date of your use of the Service, and other statistics.

# Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory. This Service does not use these "cookies" explicitly. However, the app may use third party code and libraries that use "cookies" to collect information and improve their services. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your device. If you choose to refuse our cookies, you may not be able to use some portions of this Service.

### **Service Providers**

We will make sure that the data will not be publicly displayed in the App and please be aware that the data may not be completely removed from all our system (eg: backups)

#### **Children's Privacy**
